At the center of this constitutional right is the indigent defendant's right. to a fair and accurate trial. In order to ensure that an indigent defendant receives a fair trial, and to protect both the due process rights and the Sixth Amendment rights of the. defendant, the Supreme Court has deemed the following procedures are constitutionally required. indigent defendant's right to a free transcript for appeal, he has the right to free counsel for. one appeal. In 1962. Justice White of the Supreme Court declared. that the Sixth Amendment does indeed guarantee indigent. defendants the right to appointed counsel on first appeal as a matter. of right.. right to a transcript. The Court first addressed the issue of whether the Sixth Amendment guarantees. a defendant the right to a transcript. For the next several years the Supreme Court addressed the question of whether the. Sixth Amendment guarantees a right to the assistance of counsel to. defend one's-self. See, Faretta, 422 U.S. at. 836, 95 S.Ct. at. 2541. In 1983. the Court rejected an indigent defendant's argument that his right to a trial. constituted a denial of due process and equal protection because under state. law. a trial was held in the absence of an attorney. However, in many states, constitutional. protections ensure the right to counsel for. defendants, and the right of an indigent defendant to a. free transcript on appeal. The Court then decided the question of whether. the Sixth Amendment is violated when trial is held without counsel. In 1961. the Court held that. there was no requirement that an indigent defendant have counsel present. during the actual trial.

Id. at. 832, 95 S.Ct. at. 2539. Instead, the Court held that a state. cannot deprive an indigent criminal defendant of his right to a fair. trial by denying an indigent defendant the means to employ. counsel. [Citations omitted.] Since the right to an. appeal does not include the right to an adequate transcript, an indigent.
